DATE OF FINAL PASSAGE JUN 06 2006

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN
DIEGO AUTHORIZING THE MAYOR TO RAISE PARKING
FEES AT QUALCOMM STADIUM.

WHEREAS, Qualcomm Stadium fees for renting the Stadium and special event parking [Fees] were last revised on December 8, 2003 by Resolution No. R-298695 and took effect on January 1, 2004; and

WHEREAS, these Fees are reviewed periodically to determine the appropriateness of the Fees, to generate additional revenues to cover increases in maintenance costs and other costs of providing services, and to keep the Fees in line with other facilities in California; and


WHEREAS, the current parking fee structure for major events is \$10 per car and \$20 per recreational vehicle [RV]; and

WHEREAS, a recent survey found that the average pricing for similar events at ten NFL stadiums through out the country is \$18.70 for each car and \$55 for each RV; and

WHEREAS, of the Fees on the Qualcomm Stadium fees schedule, it is proposed that effective retroactively to January 1, 2006, Maximum Parking Rates for Major Special Events inside the Stadium (Chargers Games excluded) be raised to \$16 for cars and \$46 for RV's to bring the fees more into line with similar venues throughout the country; NOW, THEREFORE,

BE IT RESOLVED, that the Mayor is authorized to raise the parking fees at Qualcomm Stadium for major stadium events (Chargers Games excluded), retroactively to January 1, 2006, to \$16 for each car and \$46 for each RV.
