BE IT RESOLVED, by the Council of the City of San Diego, that the payment of attorney's fees and costs to BayKeeper/Surfrider Foundation is hereby authorized in connection with the Second Partial Consent Decree in *United States & BayKeeper/Surfrider Foundation v.*City of San Diego, U.S. District Court No. 01-CV-0550-B, in the amount of \$301,923.44, provided that the City Auditor and Comptroller first furnishes one or more certificates indicating that the funds necessary for this expenditure are available in the City Treasury.
