

RESOLUTION NUMBER R- 301525
DATE OF FINAL PASSAGE JUN 16 2006

WHEREAS, San Diego Fire-Rescue Department has established operating procedures that require on-going training for all fire station crews; and

WHEREAS, due to budgetary shortfalls and the need for increased training the Department has sought different ways to fund its training programs; and

WHEREAS, a new course curriculum has been developed based on the department's current training requirements; and

WHEREAS, the San Diego Community College District (Miramar College) and the City of San Diego Fire-Rescue Department entered into a working agreement to establish a Fire Technology 265 Training Program; and

WHEREAS, the California Fire Fighter Joint Apprenticeship Committee program provides for state reimbursement for the hours spent by employees of the San Diego Fire-Rescue Department attending the Fire Technology 265 Training Program; and

WHEREAS, all revenue generated from the Fire Technology 265 course must be reinvested into Fire-Rescue's training programs thereby providing for further training and facility and equipment enhancements; and

WHEREAS, the training received under the Fire Technology 265 Training Program and revenue generated thereby will be used for additional training facility and equipment enhancements with no impact on the general fund; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. Authorize the Mayor to execute the agreement between the City and San Diego

Community College District (Miramar College) to implement a Fire Technology 265 program, on file in the office of the City Clerk as Document No. RR- 301525.

2. Authorize the City Auditor and Comptroller to establish a special interest-bearing fund for the Fire Technology 265 Training Program.

3. Authorize the City Auditor and Comptroller to accept, appropriate and expend the revenue for the sole purpose of enhancing the Fire Technology 265 Training Program.
