

RESOLUTION NUMBER R- 301534

DATE OF FINAL PASSAGE JUN 12 2006

WHEREAS, on JUN 12 2006, the City Council of the City of San Diego held a public hearing for the purpose of considering angle parking on San Diego Avenue; and

WHEREAS, the 1858 San Diego Avenue, LLC, requested the removal of four on-street parallel parking spaces and construct twelve on-street angle parking spaces with five landscaped islands on San Diego Avenue located at 1858 and 1866 San Diego Avenue on the corner of California Street and San Diego Avenue in the CL-6 zone of the Mid-City Communities Planned District within the Uptown Community Plan, the site is legally described as Lots 2, 3, and 4, Block 193 of Middletown according to the map made by J. E. Jackson, Map No. CC1-1874; and

WHEREAS, the Planning Commission of the City of San Diego found the proposed angle parking consistent with the San Diego Municipal Code Chapter 8, Article 6, Division 0, section 86.03; and

WHEREAS, under Charter section 280(a)(2) this resolution is not subject to veto by the Mayor because this matter requires the City Council to act as a quasi-judicial body and where a public hearing was required by law implicating due process rights of individuals affected by the decision and where the Council was required by law to consider evidence at the hearing and to make legal findings based on the evidence presented;

WHEREAS, the Council of the City of San Diego has considered all maps, exhibits, and written documents contained in the file for this project on record in the City of San Diego, and has considered the oral presentations given at the public hearing; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it permits the angle parking on San Diego Avenue, a copy of which is on file in the office of the City Clerk as
