

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, stating for the record that the information contained in the Environmental Impact Report, No. 96-0333, Addendum to EIR No. 96-0333, and Environmental Impact Report Addendum No. 100693, including any comments received during the public review process, have been previously reviewed and considered by this Council and it is determined that this subsequent discretionary approval of the amendments to the Land Development Code by Ordinance Numbers O-2006-133, O-2006-134, and O-2006-135, do not involve any new direct, indirect, cumulative impacts, substantial changes, or new information of substantial importance that would warrant any additional environmental review, new CEQA Findings, or a Statement of Overriding Consideration.
