A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ACCEPTING THE FISCAL YEAR 2007 BUDGET REPORTS FOR THE EXISTING BUSINESS IMPROVEMENT DISTRICTS.

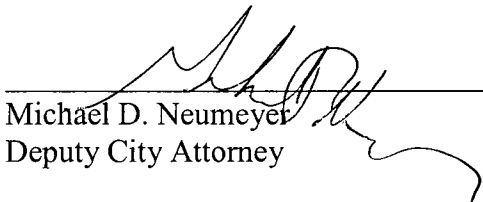
WHEREAS, the City Council, in accordance with the Parking and Business Improvement Association Law of 1989 (California Streets and Highways Code section 36500 et seq.), wishes to continue the promotional activities of the existing Business Improvement Districts in the City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the City Council hereby accepts the Fiscal Year 2007 Budget Report for each existing Business Improvement District [District] in the City of San Diego. Those Districts are as follows: Adams Avenue; City Heights; College Area; Diamond; Downtown; El Cajon Boulevard Central; El Cajon Boulevard Gateway; Gaslamp; Hillcrest; La Jolla; Little Italy; Midway; Mission Hills; North Park; Ocean Beach; Old Town; Pacific Beach; and San Ysidro.

2. That a full report describing each District, including the boundaries of, assessment rates of, and activities to be undertaken within each District, from July 1, 2006 through June 30, 2007, is available for review in the Office of the City Clerk.
