WHEREAS, since 1983, Richard J. Kerman as been an attorney at the Law Offices of Richard J. Kerman here in San Diego, specializing in general civil and transactional matters, litigation, estate planning, counseling of non-profit public benefit organizations and general criminal defense; and

WHEREAS, during his time as an attorney, Richard J. Kerman has served as pro bono legal advisor to numerous community and social service organizations including the Human Dignity Fund, Bienestar San Diego, the Committee Organizing San Diego/Tijuana Alliance (COSTA), the Imperial Court de San Diego, Design Industry for AIDS-San Diego Chapter (DIFFA), PACTO Latino AIDS Organization, Stepping Stone, Gay Lesbian Latinos Con Orgullo (GLLO) and GLBT Vote 2000; and

WHEREAS, Richard J. Kerman was chosen by the city manager of the City of San Diego to serve on the 1999 Blue Ribbon Task Force set up to select a new police chief and on the 1992-93 San Diego Board of Fiscal Advisors to advise on select city contracts in matters involving long-term public interest; and


