A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF SAN DIEGO RATIFYING THE BARRIO LOGAN
REDEVELOPMENT PROJECT AREA COMMITTEE
ELECTION RESULTS OF MAY 17, 2006.

WHEREAS, pursuant to California Health and Safety Code section 33386, the
Redevelopment Agency of the City of San Diego [Agency], through its staff, is to consult with
the Project Area Committee [PAC] for a three-year period after the adoption of the
Redevelopment Plan, and for one-year extensions thereafter by approval of the Council of the
City of San Diego;

WHEREAS, the Council of the City of San Diego [Council] by Resolution No. R-296209
amended the Procedures for the Formation of PAC for the Barrio Logan Redevelopment Project
[Project];

WHEREAS, the Council of the City of San Diego by Resolution No. R-301308,
authorized a one-year extension of the Barrio Logan Project Area Committee and authorized
staff to notice and conduct the annual PAC election in accordance with the PAC bylaws; and

WHEREAS, election of the Project Area Committee was properly conducted on May 17,
2006; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the persons elected as members of the Project Area Committee for the Barrio
Logan Redevelopment Project, as noted by the City Clerk's verification of the
election results of May 17, 2006 attached as Exhibit A and incorporated by this
reference, are approved as newly elected members to the PAC.

- 2. That the Council concurs that the election results of May 17, 2006 are valid and binding in accordance with the procedures adopted by Resolution No. R-296209.


