WHEREAS, the San Diego Watercolor Society is hosting "Splash," a third annual exhibit and reception at its Showcase Gallery to encourage art among children and to celebrate their talent by showcasing posters from the 2006 Children's Water Conservation Poster Contest alongside members' artwork; and

WHEREAS, the San Diego Watercolor Society is recognizing each student artist with a certificate and paint brush to motivate and inspire growth of artistic abilities among children; and

WHEREAS, throughout the month of June, the San Diego Watercolor Society will continue displaying posters from the 2006 Children's Water Conservation Poster Contest as part of its "Splash" exhibit; and

WHEREAS, the San Diego Watercolor Society also held a Paint-Out Demonstration with artists at the Water Conservation Garden's Spring Garden Festival, lead by artist Char Cee Colosia, whose colorful and exciting work is shown in galleries throughout California, Arizona and Mexico. She has led many outdoor workshops, inspiring other artists to paint freely in an

outdoor environment and to capture the essence of the moment. The demonstration highlighted the San Diego Watercolor Society's support for water-efficient plants and flowers and celebrated May as Water Awareness Month; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby recognize and appreciate the San Diego Watercolor Society's support of the City's Water Conservation Program.
