WHEREAS, the San Diego Housing Federation was formed in 1990 as the Nonprofit Federation for Housing and Community Development to coordinate an organized approach for community groups to advocate for and grow proficient in developing affordable housing and economic opportunities for lower income people; and

WHEREAS, working together as a coalition of affordable housing developers, advocates and other organizations, the San Diego Housing Federation has promoted the creation of quality affordable housing focused on lower income families and people in need for 16 years; and

WHEREAS, the City of San Diego joins with the San Diego Housing Federation in recognizing that safe, affordable housing is of vital importance to ensuring that all residents of San Diego have housing choices that are consistent with what they can reasonably afford to pay; and

WHEREAS, the City of San Diego also believes that creating and supporting affordable housing and revitalizing neighborhoods contributes to the quality of life throughout San Diego; and

WHEREAS, the City of San Diego supports efforts to maintain and provide adequate housing opportunities for residents of all income levels, especially the more than 200,000 residents of San Diego County who have critical housing needs; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby salute the work of the San Diego Housing Federation and the many non-profit and for-profit developers who have partnered to develop affordable housing.

BE IT FURTHER RESOLVED, that the week of June 11-17, 2006, be and is hereby proclaimed to be "AFFORDABLE HOUSING WEEK" in the City of San Diego.
