DATE OF FINAL PASSAGE JUN 22 2006

WHEREAS, FaceLift is a "Spruce-Up-a-Block-in-a-Day" event that is accomplished through the help of community volunteers, neighborhood associations, and local business leaders acting as a catalyst to build pride and equity without displacement and as a way to strengthen the neighborhood association for future activities; and

WHEREAS, every year, the locally-based FaceLift Committee selects a one-block radius in the City Heights area to receive a makeover during this one-day event held in June; and

WHEREAS, FaceLift gives priority to senior citizens, disabled persons and low-income families that need assistance to make improvements to their homes; and

WHEREAS, this year FaceLift has selected the Colina del Sol neighborhood of City Heights in Council District 7, and Community HousingWorks, partnering with sponsor Councilmember Jim Madaffer, is making significant improvements to this neighborhood from the inside out; and

WHEREAS, Community HousingWorks, along with hundreds of volunteers, paints 10 to 15 homes in this designated neighborhood, and also provides additional improvements by providing the homes with minor landscaping upgrades, including debris removal and tree and flower planting; and

WHEREAS, Community HousingWorks also mobilizes neighbors for a neighborhood clean-up of trash and debris in and around the area; and


WHEREAS, the eleven previous FaceLift days have mobilized more than 3,800 volunteers to paint 307 homes and haul away more than 320 tons of trash in City Heights communities since 1995; and

WHEREAS, for more than twenty years, Community HousingWorks has been committed to increasing the homeownership rate, generating community leaders, and investing in the diverse communities of City Heights. Community Housing Works accomplishes these goals through homebuyer and financial fitness education, affordable rental housing, flexible financing options, leadership training and community revitalization events; and

WHEREAS, companies organize team-building events around FaceLift by sponsoring a house and competing with other companies for FaceLift "Best Of" awards. Local neighborhood groups and other non-profits such as the Fairmount Village Neighborhood Association, Project C.L.E.A.N. and Rebuilding Together San Diego pitch in to make FaceLift a stronger and more successful grassroots event; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the citizens of San Diego do hereby proclaim June 10, 2006, as "**COMMUNITY HOUSINGWORKS FACELIFT DAY**" in the City of San Diego.
