A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING ADDITIONAL FUNDS FOR OUTSIDE LEGAL COUNSEL FOR COUNCIL MEMBER JIM MADAFFER RELATING TO FINANCIAL AND DISCLOSURE ISSUES AND PENSION INVESTIGATIONS AND LITIGATION

WHEREAS, the Council of the City of San Diego previously authorized \$327,231.27 in total to pay for attorney's fees to the law firm of Akin Gump Strauss Hauer and Feld, LLP to provide independent representation to Councilmember Jim Madaffer related to financial and disclosure issues and pension investigations and litigation; and

WHEREAS, the attorney for Councilmember Madaffer has left the firm of Akin Gump and joined the firm of Paul Hastings Janofsky & Walker, LLP; and

WHEREAS, these investigations by state and federal agencies are continuing; NOW THEREFORE

BE IT RESOLVED, that the Council authorizes the additional expenditure of an amount not to exceed \$100,000 for the firms of Akin Gump Strauss Hauer and Feld, LLP and Paul Hastings Janofsky & Walker, LLP for the purpose of paying attorney's fees incurred in Fiscal Year 2006 and \$150,000 for the firm of Paul Hastings Janofsky & Walker, LLP for the purpose of paying attorney's fees to be incurred in Fiscal Year 2007 for the representation of Councilmember Jim Madaffer related to the issues described above, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED that the Auditor and Comptroller shall be authorized to fund these expenditures solely from General Fund revenues.
