DATE OF FINAL PASSAGE JUL - 5 2006

WHEREAS, in June of 2001, the City Council adopted the first 5-year Business Plan governing the operation of the City maintained golf facilities; and

WHEREAS, this plan outlined key issues facing the daily operation of the three City golf complexes and outlined key capital needs and established the green fee structure for the five years covered by the plan; and

WHEREAS, during the five years of the plan, several key changes occurred in the Golf Division; and

WHEREAS, the primary goal of the proposed Business Plan is to provide a guideline for Golf Operations over the next five years; and

WHEREAS, the plan must maintain a Golf Enterprise Fund that addresses many operation needs while establishing clear policies and procedures that ensure the long-term financial sustainability of the Golf Enterprise Fund; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Golf Operations Business Plan is approved.
2. That the Mayor, or his designee, is authorized to review rate revisions annually and make adjustments as needed in accordance with Administrative Regulation 95.25.

3. That staff is directed to return to the Council with a program for low income fee waiver and senior rates.
