WHEREAS, the plan must maintain a Golf Enterprise Fund that addresses many operation needs while establishing clear policies and procedures that ensure the long-term financial sustainability of the Golf Enterprise Fund; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Golf Operations Business Plan is approved.
- 2. That the Mayor, or his designee, is authorized to review rate revisions annually and make adjustments as needed in accordance with Administrative Regulation 95.25.

3. That staff is directed to return to the Council with a program for low income fee waiver and senior rates.
