A RESOLUTION OF THE SAN DIEGO CITY COUNCIL  
APPOINTING TRACY JARMAN TO THE POSITION OF  
CHIEF OF THE SAN DIEGO FIRE-RESCUE DEPARTMENT.

WHEREAS, Charter section 58 provides that the Chief of the Fire Department shall be appointed by the City Manager and the appointment shall be confirmed by a majority of the Council; and

WHEREAS, Charter section 260(b) provides that all executive authority, power, and responsibilities conferred upon the City Manager in article V, including Charter section 58, shall be transferred to, assumed, and carried out by the Mayor during the time period under which the City operates as a Mayor-Council form of government; and

WHEREAS, Chief Jeff Bowman has resigned from the position as Chief of the San Diego Fire-Rescue Department resulting in a vacancy in the position; and

WHEREAS, over 30 well qualified candidates applied for the position; and

WHEREAS, Tracy Jarman, a 22-year veteran of the San Diego Fire-Rescue Department, was the unanimous choice of a five-member selection committee; and

WHEREAS, the Mayor has appointed Tracy Jarman to the position of Chief of the San Diego Fire-Rescue Department; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council hereby confirms the appointment of Tracy Jarman to be Chief of the San Diego Fire-Rescue Department of the City of San Diego.
