DATE OF FINAL PASSAGE JUL - 5 2006

WHEREAS, the San Diego Urban Corps will be celebrating its second annual work exchange program with the Québec-Amerique Pour la Jeunesse; and

WHEREAS, in 2004, the San Diego Urban Corps partnered with the Québec-Amerique Pour la Jeunesse, creating a program to benefit the youth of Québec and San Diego through an exchange program that provides students with language lessons and the opportunity to assist in city beautification projects; and

WHEREAS, the program began in June 2005 when the Urban Corps welcomed ten young men and women from Québec, Canada. These young people worked alongside Urban Corps members on projects throughout San Diego such as tree planting, recycling at Petco Park, trail building, and graffiti removal; and

WHEREAS, in July of 2005, the Urban Corps of San Diego sent the first group of young men and women from the San Diego program to Québec, Canada, to work on environmental improvement projects throughout the City of Québec; and


WHEREAS, the Urban Corps of San Diego/Québec-Amerique pour la jeunesse Exchange Program began its second annual work exchange on May 28, 2006, when nine young men and women from San Diego traveled to Québec City where they worked on projects to help beautify the City of Québec and receive French language lessons; and

WHEREAS, the Urban Corps of San Diego will be welcoming nine young men and women and two supervisors from Québec City for three weeks who will work alongside the Urban Corps youth on projects designed to improve the beauty and appearance of San Diego, while receiving English Lessons at the John Muir Charter School; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby congratulate and offer appreciation to the Urban Corps of San Diego and the Québec-Amerique Pour la Jeunesse on the success of their second annual work exchange program.

BE IT FURTHER RESOLVED, that June 27, 2006, be and is hereby proclaimed to be **"THE URBAN CORPS OF SAN DIEGO/ QUÉBEC-AMERIQUE POUR LA JEUNESS EXCHANGE PROGRAM DAY"** in the City of San Diego.
