BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. That the Mayor, or his designated representative, is hereby authorized and empowered for and on behalf of the City, to make an application to the Department of Homeland Security – Federal Emergency Management Agency’s (FEMA) U.S. Fire Administration for a grant from the Assistance to Firefighters Grant Program for funding for an Operations and Firefighter Safety Program.

2. That the Mayor, or his designated representative, is hereby authorized and empowered to take all necessary actions to secure grant funding for the Operations and Firefighter Safety Program.

3. That the City Auditor and Comptroller is hereby authorized to accept, appropriate and expend grant funds upon award of the grant and receipt of grant funds for an Operations and Firefighter Safety Program.

4. That the City Auditor and Comptroller is hereby authorized to accept an expend \$175,000 granted by the Indian Gaming Local Community Benefit Committee (IGLCBC) to the San Diego Fire-Rescue Department to help fund a Portable Live Fire Training Unit.
