A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AMENDMENT TO RESIDENTIAL PERMIT PARKING AREA E HILTON PLACE IN THE SAN DIEGO MESA COLLEGE AREA

WHEREAS, the City of San Diego has established a Residential Permit Parking Program to alleviate the adverse effects of vehicle congestion caused by long-term parking by non-residents in residential neighborhoods;

WHEREAS, a Residential Permit Parking Area was established in the San Diego Mesa College area [Permit Parking Area E] in 2002;

WHEREAS, a majority of the residents of the 7000-block of Hilton Place, currently within in Permit Parking E, have submitted a petition requesting that block to be removed from Permit Parking Area E;

WHEREAS, as detailed in Report to Council No. 06-076, the evidence regarding the impacts of non-resident parking on the 7000-block of Hilton Place meet criteria in Municipal Code section 86.2005 for removing that block from Permit Parking Area E;

AND WHEREAS, as detailed in Report to Council No. 06-076, the Mayor has followed the procedures specified in Municipal Code sections 86.2006 and 86.2007 for considering removal of the 7000-block of Hilton Place from Permit Parking Area E;

BE IT RESOLVED, by the Council of the City of San Diego that pursuant to the authority conferred by and in accordance with the requirements of Division 20 of Article 6 of


Chapter 8 of the San Diego Municipal Code, the 7000-block of Hilton Place, between Marlesta Drive and the cul-de-sac, is hereby removed from Residential Permit Area E.

BE IT FURTHER RESOLVED, BE IT FURTHER RESOLVED, that the Mayor or his designee is authorized to remove of all signs and markings on both sides of the 7000-block of Hilton Place, between Marlesta Drive and the cul-de-sac, and to take other necessary action, to implement the removal of the 7000-block of Hilton Place from Permit Parking Area E.

BE IT FURTHER RESOLVED, that the Council of the City of San Diego finds that this activity is not a project because this activity does not result in a direct or reasonable foreseeable indirect physical change in the environment, and is therefore not subject to the California Environmental Quality Act [CEQA] pursuant to State CEQA Guidelines Section 15060(c)(2).
