WHEREAS, the House of Hospitality Association, a public benefit non-profit corporation, serves the community of San Diego by promoting the rich cultural and recreational resources of Balboa Park, providing information for visitors from around the world, and supporting Park-wide activities, services, and collaborations and celebrates its 85th year in Balboa Park with an annual meeting on June 15, 2006; and

WHEREAS, the House of Hospitality Association manages and maintains the award-winning National Historic Landmark House of Hospitality building on the Prado in Balboa Park — originally built for the 1915-16 Panama-California Exposition, remodeled for the 1935-36 California Pacific International Exposition, and reconstructed in 1997 — and has garnered numerous international, national and regional awards for its historic preservation, architecture and landscapes; and

WHEREAS, the House of Hospitality Association is the “living room” for the City of San Diego and, since 1935, thousands of wedding ceremonies and other special events have taken place here, and the elegant Prado Restaurant has become a premier location for celebrations such as birthdays, anniversaries and graduations; and


