DATE OF FINAL PASSAGE JUL - 5 2006

WHEREAS, the Park Manor Suites Hotel celebrates its 80th anniversary on July 1st with an Anniversary Gala on its rooftop deck; and

WHEREAS, the Park Manor Suites Hotel is ideally situated for visitors to the area on the western edge of the beautiful "jewel" of San Diego – Balboa Park, close to the San Diego Zoo, Hillcrest, downtown, adjacent to freeways and public transit, and, during the "Roaring 20's" and Prohibition in the early 20th century, it was a popular stopping off point for the "Hollywood Set" commuting from Rosarito Beach and Del Mar; and

WHEREAS, the Park Manor Suites Hotel was designed by Frank P. Allen, Jr., the chief architect for the 1915 Panama-California Exposition on the grounds of Balboa Park who went on to design many buildings for the 1935 Exposition; and

WHEREAS, the Park Manor Suite Hotel recently underwent a \$2.5 million renovation and seismic retrofit of the brick building, the addition of two new elevators, a renovated penthouse area, new furniture in each of its 74 guest rooms, and new "historic" touches throughout the building; and

WHEREAS, the Park Manor Suites Hotel was purchased in 1978 by Dr. Stanley Willis, and, after its recent extensive renovation and ongoing improvements, the hotel has been restored to the same level of grandeur that it attained during its heyday in the style of the Italian Renaissance; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby recognize the accomplishments of the Park Manor Suites Hotel and commends its owner and staff for their efforts to provide a destination for visitors and special events in the City of San Diego.

BE IT FURTHER RESOLVED, that July 1, 2006, be and is hereby proclaimed to be "PARK MANOR SUITES HOTEL 80TH ANNIVERSARY DAY" in the City of San Diego.
