WHEREAS, Father Rasura has been committed to the Blue Army of Fatima, the faithful devoted to Our Lady of Fatima, in which the traveling statue of Our Lady of Fatima arrived at Our Lady of Guadalupe Catholic Church. Families were chosen to have the statue in their homes for a few days, during which Father Rasura would arrive and recite the rosary for the group; and

WHEREAS, Father Rasura has been involved in the jail ministry for the past 17 years at both the federal and City jails downtown; and

WHEREAS, Father Rasura has been involved with the Confraternity of Christian Doctrine (CCD) classes at St. Joseph's Cathedral, conducting classes for high school students to teach them the tenets of their Catholic faith; and

WHEREAS, Father Rasura has had a long-standing association with the Kiwanis Club for the past 40 years, receiving the Kiwanian of the Year award in 1995; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby commend Father Rasura for his outstanding service, leadership and commitment to the people of San Diego.
