DATE OF FINAL PASSAGE JUL 18 2006

WHEREAS, Joyce Lane is retiring from the City of San Diego, ending a distinguished 18-year career which began September 6, 1988, and during which she faithfully served the Office of the City Clerk as Elections Analyst, Deputy Director, and Assistant City Clerk; and

WHEREAS, Joyce Lane professionally and impartially administered many highly political, and sometimes controversial, election activities, including the only recall election in the history of the City of San Diego to date, and the 2004 District 4 special election, which was conducted almost entirely by the Office of the City Clerk and was the first election so administered in many decades; and

WHEREAS, Joyce Lane proficiently and equitably aided participants in multiple initiative efforts, Charter amendments, referendums, other petition processes, and oversaw numerous Election Centrals and inauguration events for elected officials; and

WHEREAS, Joyce Lane initiated and coordinated the updating and rewriting of the City of San Diego's election laws, including the creation of the Municipal Lobbying Ordinance to replace antiquated regulation of municipal advocacy; and

WHEREAS, Joyce Lane implemented the creation of the General Records Disposition Schedule for records common to all City departments to provide for consistent retention of records across the City; and instituted multiple technological improvements in the Office of the City Clerk, including the development of the City Clerk's web page, the on-line filing of

campaign disclosure statements, and other advancements providing greater access to public documents; and

WHEREAS, Joyce Lane promoted women's contributions in society and in the workplace by assisting with the coordination of such events as Take Our Daughters to Work Day, the celebration of women's suffrage; and as chair and member of the City's Women Employees Association; and

WHEREAS, Joyce Lane performed her job by all measures with courtesy, integrity, and perseverance; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby recognize and commend Joyce Lane for her dedication, service, and contributions to the City of San Diego.

BE IT FURTHER RESOLVED, that July 11, 2006, be and is hereby proclaimed to be "JOYCE LANE DAY" in the City of San Diego.
