A RESOLUTION APPROVING PLANS AND SPECIFICATIONS; AUTHORIZING AWARD OF PUBLIC WORKS CONTRACT; AND TAKING RELATED ACTIONS.

WHEREAS, The City of San Diego requires the services of a contract to make improvements to street lighting and traffic signals at various, but yet to be determined, locations throughout the City.

WHEREAS, the Mayor has advertised for bids in accordance with law and determined that Southwest Traffic Signal Service Inc. is the lowest responsible and reliable bidder;

AND WHEREAS, the costs of advertising for bids on an annual basis frequently outweigh the savings gained by seeking new bids each year;

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That, having advertised for bids in accordance with law, the Mayor is authorized to award the As Needed Construction of Street Lighting and Traffic Signal Improvements at Various Locations contract to the Southwest Traffic Signal Service Inc., in an amount not to exceed \$1,000,000 for the period between April 10, 2006 and April 9, 2007.
- 2. That the Mayor is hereby authorized to renew the contract on the same terms for one additional year, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer;

- 3. That the expenditure of \$50,000 from Fund No. 30300, Transnet, CIP No. 68-011.0, Fiscal Year 2005 traffic signal modifications/modernization at various locations, is hereby authorized.
- 4. That the City Auditor and Comptroller is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
- 5. That the Council of The City of San Diego finds that this activity is not a project because this activity is a governmental fiscal activity that does not involve a commitment to a specific project which may result in a potentially significant physical impact on the environment and therefore this activity is not subject to the California Environmental Quality Act pursuant to State CEQA Guidelines Section 15060(c)(3).
