## INTEROPERABLE COMMAND AND CONTROL COMMUNICATIONS SYSTEM

WHEREAS, the City of San Diego, via the San Diego Police Department, has been selected to administer a 2004 Technology grant from the U.S. Department of Justice, Office of Community Oriented Policing Services (COPS) to develop a far-southwest region Interoperable Command and Control Communications System (3CS); and

WHEREAS, based on a competitive bidding process, City wishes to expend a maximum of \$5 million with Harris Corporation for microwave equipment that serves as the infrastructure for the project;

NOW THEREFORE, BE IT RESOLVED, by the Council of the City of San Diego, that the City Auditor, the Mayor (or his designee), and the Chief of Police be and hereby are authorized and empowered, for and on behalf of the City of San Diego, to enter into and manage this expenditure of grant funds from the U.S. Department of Justice.

BE IT FURTHER RESOLVED, that the Council hereby authorizes the Auditor, the Mayor (or his designee) and the Chief of Police to execute all aspects of program operation, including any amendments, extensions, or renewals, for a period of up to five years, provided funding is made available by the U.S. Department of Justice, and to certify that the City will comply with all applicable statutory or regulatory requirements related to said program.

BE IT FURTHER RESOLVED, that any resources received and/or expended hereunder shall be used to supplement, and not to supplant, expenditures controlled by this body.
