BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his designee, is authorized and empowered to execute, for and on behalf of the City of San Diego, a deed conveying to San Diego Gas & Electric Company, a corporation, an easement for the purpose of constructing, reconstructing, replacing, repairing, maintaining and using retaining

walls and/or protective barriers to protect its facilities upon or adjacent to Lot 18 of Employment Center development Unit No. 2B, according to Map thereof No. 10945, filed May 21, 1984, in the Office of the County Recorder of San Diego County, as more particularly described in said deed on file in the office of the City Clerk as Document No. RR
