DATE OF FINAL PASSAGE JUL 18 2006

WHEREAS, the Interfaith Shelter Network has devotedly served San Diego's homeless population for over 15 years; and

WHEREAS, the Interfaith Shelter Network coordinates the efforts of participating congregations, social service agencies, and government programs to provide shelter and other resources to help move the homeless toward self-sufficiency; and

WHEREAS, more than 6,750 homeless individuals have been served by over 4,000 volunteers from 120 congregations countywide and offered shelter and other resources through the Network's Rotational Shelter Program; and

WHEREAS, the Interfaith Shelter Network provides San Diego's homeless with food, shelter, clothing, counseling, transportation, and transitional housing; and

WHEREAS, the Interfaith Shelter Network opened El Nido Transitional Living Program, formerly the Wings program, for homeless battered women and children, which has served 145 families since 1997; and

WHEREAS, the goal of the Interfaith Shelter Network is to completely eliminate homelessness in the urban areas of San Diego through cooperative programs with other organizations; and

WHEREAS, the City of San Diego is committed to recognizing and honoring the many fine individuals and organizations throughout the region who dedicate themselves to the

betterment of the community, and the Interfaith Shelter Network is one such caring and generous network of organizations; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the City of San Diego does hereby proclaim May 19, 2006, "INTERFAITH SHELTER NETWORK DAY" in San Diego in honor of the Interfaith Shelter Network's 20 years of leadership and service to the homeless community.
