A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A 10-YEAR LEASE AGREEMENT WITH LEO PIERSON TO OPERATE AND MAINTAIN THE MORLEY FIELD DISC GOLF COURSE IN BALBOA PARK.

WHEREAS, the City Council's Land Use and Housing Committee has authorized exclusive negotiations with Leo Pierson, an individual, for a 10-year lease of the Morley Field Disc Golf Course on Pershing Drive near Redwood Street in Balboa Park, in the City of San Diego, County of San Diego, as more particularly described in Exhibit A to the proposed lease; and

WHEREAS, the City and Leo Pierson have negotiated a 10-year lease agreement under terms that meet or exceed current comparable market rents, as determined by City valuation staff; and

WHEREAS, the City's Park and Recreation Department concurs with the terms of the proposed lease; and

WHEREAS, under the terms of the proposed lease agreement, Leo Pierson will assume maintenance obligations of the City projected to save the City \$10,000 per year; and

WHEREAS, under the proposed lease agreement, Leo Pierson will provide approximately \$300,000 in capital improvements to the property; and

WHEREAS, the operation and maintenance of the Morley Field Disc Golf Course benefits the public health, safety or general welfare; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Mayor is authorized to execute, for and on behalf of The City of San Diego, a 10-year lease agreement with Leo Pierson, an individual, for operating and maintaining the Morley Field Disc Golf Course located on Pershing Drive near Redwood Street in Balboa Park, San Diego, California, under the terms and conditions set forth in that lease agreement on file in the office of the City Clerk as Document No. RR-301659.
