DATE OF FINAL PASSAGE AUG - 4 2006

WHEREAS, lesbian, gay, bisexual, and transgender San Diegans are commemorating their community's rich history of courage, spirit, achievement, and activism by organizing the 32nd annual Lesbian, Gay, Bisexual, Transgender Pride celebration, this year under the banner of "Pride, Equality – No Turning Back!"; and

WHEREAS, this year's event, held the weekend of July 28 through July 30 and featuring a rally, parade and festival, promises to be the biggest and brightest celebration to date, with an estimated attendance of more than 200,000 people at the weekend's activities; and

WHEREAS, each year the rally, parade and festival—the largest annual civic event in San Diego—draw an ever increasing number of San Diegans and visitors to Hillcrest and Balboa Park, with more than 100,000 exuberant spectators lining the parade route along University and Sixth Avenues; and

WHEREAS, lesbian, gay, bisexual, and transgender individuals have made valuable contributions in areas that include business and commerce, arts and culture, the military, community volunteerism and leadership, religion, medicine, law, athletics, civil rights, education, and they continue to lead the larger community in addressing and remedying the many problems posed by issues such as the HIV/AIDS pandemic, hate crimes, and discrimination; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the citizens of San Diego, does hereby recognize the many civic contributions of the lesbian, gay, bisexual, and transgender community in San Diego, and encourages all people to share in the pride of our City's diverse citizenry by participating in the 32nd annual San Diego LGBT Pride rally, parade, and festival.

BE IT FURTHER RESOLVED, that the week of July 24 to July 30, 2006, be and is hereby proclaimed to be "**LESBIAN, GAY, BISEXUAL, TRANSGENDER PRIDE WEEK**" in the City of San Diego.
