RESOLUTION TO AUTHORIZE FUNDING FOR SEA WORLD DRIVE AND INTERSTATE 5 INTERCHANGE IMPROVEMENT PROJECT AND EXECUTE CONSULTANT AGREEMENT WITH DMJM HARRIS, INC.

BE IT RESOLVED, by the Council of the City of San Diego, that the City Auditor and Comptroller is authorized to appropriate \$1,000,000 from Fund 10501, Sea World Traffic Mitigation Fund to CIP 52-706.0, Sea World Drive and Interstate 5 Interchange Improvements; and

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to increase the Fiscal Year 2006 Capital Improvement Program Budget for CIP 52-706.0, Sea World Drive and Interstate 5 Interchange Improvements by \$1,000,000; and

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to expend an amount not to exceed \$1,000,000 from Fund 10501, Sea World Traffic Mitigation Fund, CIP 52-706.0, Sea World Drive and Interstate 5 Interchange Improvements for the purpose of preparing a Project Study Report [PSR] and associated surveying, engineering, and administrative costs, contingent upon the Auditor and Comptroller certifying that funds are available; and

BE IT RESOLVED, that the Mayor is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with DMJM Harris, Inc., for the preparation of a PSR for Sea World Drive and Interstate 5 Interchange Improvements for an amount not to exceed \$624,482, from Fund 10501, Sea World Traffic Mitigation Fund CIP 52-706.0, Sea World Drive and Interstate 5 Improvements, contingent upon the Auditor and Comptroller certifying that

funds are available in CIP 52-706.0.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.

BE IT FURTHER RESOLVED, that this activity is statutorily exempt from CEQA pursuant to State CEQA Guidelines section 15262.
