WHEREAS, Section 85.04 the City of San Diego Municipal Code authorizes the City Council, by resolution, to prohibit large commercial vehicles from using any street or portion thereof;

WHEREAS, all the residents of the portion of Beardsley Street between Kearny Avenue and Commercial Avenue submitted a petition requesting that such a prohibition be established for that portion of Beardsley Street;

WHEREAS, the Mayor has reviewed this petition and determined that this prohibition can be implemented without compromising traffic circulation or safety;

AND WHEREAS, the Southeastern San Diego Planning Committee unanimously voted to support this petition, NOW THEREFORE,

BE IT RESOLVED, by Council of the City of San Diego, that the Mayor be and he is hereby authorized and empowered to establish a prohibition of commercial vehicles with a rated capacity of five tons or more on Beardsley Street between Kearny Avenue and Commercial Street.

BE IT FURTHER RESOLVED, that this activity is the minor modification of an existing facility with no expansion beyond the existing use and therefore exempt from CEQA pursuant to State to CEQA Guidelines section 15301.
