WHEREAS, the San Diego Surf Cup has sponsored a tournament for boys and girls in the San Diego region for twenty-six years and another girls-only tournament for thirteen years; and

WHEREAS, the San Diego Surf Cup XXVI for Boys and Girls ages 9 to 18 will take place July 29 to 31, 2006, and August 5 to 7, 2006; and

WHEREAS, the San Diego Surf Girls Cup XIII for girls ages 8 to 18 will take place November 24 to 26, 2006; and

WHEREAS, the San Diego Surf Cup has become a vital instrument in promoting and supporting the economic vitality of the San Diego economy and the surrounding communities by generating an economic impact of more than \$19.53 million annually; and

WHEREAS, the San Diego Surf Cup Days in 2005 was attended by 126,057 and brought 16,613 visitors from out of town, resulting in 17,838 hotel room-nights booked; and

WHEREAS, San Diego Surf Cup has brought international recognition to San Diego by promoting excellence in youth soccer and by bringing national attention from college coaches around the United States; and

WHEREAS, San Diego Surf Cup puts on exciting tournaments every year for the full enjoyment of the citizens of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, hereby proclaims July 29-31, 2006, August 5-7, 2006, and November 24-26, 2006 as "SAN DIEGO SURF CUP DAYS" in the City of San Diego.
