WHEREAS, during Hal Sadler's tenure on the Center City Development Corporation [CCDC] Board, he oversaw the completion of several major projects, including the San Diego Downtown Community Plan adoption; the start of restoration for the Balboa Theatre; and the openings of Petco Park, Broadway 655, the Omni Hotel, and the Hotel Solamar; and

WHEREAS, as Chairman of the Board at Tucker Sadler, Mr. Sadler has over 47 years experience of leadership in architectural design. He has supervised the planning, programming, and design for numerous projects in San Diego, which include the renovation of the U.S. Grant Hotel, the Paul Harter Veterinarian Clinic at the San Diego Wild Animal Park, the Master Plan and Medical & Clinical Teaching Facility for the University of California, San Diego, and the Security Pacific National Bank and Bank of America in downtown; and

WHEREAS, Mr. Sadler's service to San Diego extends far beyond the architecture and skyline of San Diego and into the community through his involvement and leadership in several organizations. Mr. Sadler has served as the Chairman of the CCDC, the City of San Diego Parks and Recreation Board, San Diego Convention Center and Visitors Bureau, the City of San Diego Facilities Committee, as well as many others. Also, Mr. Sadler has been on the Board of Directors for, such organizations as the La Jolla Cancer Foundation, the Armed Forces YMCA, the Donald N. Sharp Memorial Hospital, and the San Diego Chamber of Commerce; and

WHEREAS, Mr. Sadler has received the California Council of the American Institute of Architects Public Service Award, the American Institute of Architecture Lifetime Achievement Award, the Lambda Alpha Crystal Globe Award for Lifetime Achievement, and was elected to the College of Fellows of the American Institute of Architects in 1976; NOW, THEREFORE,

BE IT RESOLVED, by the City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby congratulate and offer appreciation to Hal Sadler.
