DATE OF FINAL PASSAGE AUG - 4 2006

WHEREAS, Gil Johnson was originally appointed to the Board of Directors of Center City Development Corporation [CCDC] in 1993 by Mayor Susan Golding. He served on the board for six years, and then subsequently stepped down to pursue his private sector endeavors. Gil Johnson was reappointed in 2000 by Mayor Dick Murphy to CCDC. Gil Johnson has helped shape downtown San Diego through his 12 years of service with CCDC; and

WHEREAS, while on the CCDC Board of Directors, Gil Johnson served as director, treasurer, and vice chair. Gil Johnson also assisted in the development of CCDC's "five-year plan," a business strategy that provided a blueprint for both fiscal and physical matters of Downtown; and

WHEREAS, during Gil Johnson's tenure, the CCDC oversaw the evolution of East Village, the revitalization of Little Italy, and the restoration of the Balboa Theatre; and

WHEREAS, Gil Johnson's service to San Diego extends past his position with CCDC, as he continues to work on improving San Diego through his participation with several other community organizations. He has chaired both the Advisory Committee for Culture and Diversity for the City's Arts and Culture Commission and the Prop MM oversight committee that directed the \$1.5 million building and remodeling of schools throughout the San Diego Unified School District. He is also a board member of the San Diego Regional Economic Development Corporation and the United Way. Gil Johnson currently serves as a member of the

Model Schools Joint Powers Authority in City Heights and sits on the Small Business Advisory Council for the State of California; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby congratulate and offer appreciation to Gil Johnson.

BE IT FURTHER RESOLVED, that June 28, 2006, be and is hereby proclaimed to be "GIL JOHNSON DAY" in the City of San Diego.


