
BE IT RESOLVED, by the Council of the City of San Diego, as follows

- 1 That the plans and specifications for the Tecolote Canyon Mitigation Project, filed in the office of the City Clerk as Document No <u>W,O, 764081</u>, are approved.
- 2 That after advertising for bids in accordance with law, the Mayor or his designee is authorized to award a contract for the Tecolote Canyon Mitigation Project to the lowest responsible and reliable bidder, based on actual low cost received, in an amount not to exceed \$508,000.
- 3 That the expenditure of an amount not to exceed \$508,000 from the operating budget of Sewer Revenue Fund No. 41506 is authorized, solely and exclusively to provide funds for the Project and related costs
- 4. That upon completion of the Project, the City Auditor and Comptroller is hereby authorized to return any unexpended funds to the appropriate reserve.
- 5 That the Council further states for the record that the information contained in EIR No 6020 (Canyon Sewer Cleaning Program), including any comments received during the public review process, has been previously reviewed and considered by this Council and it is determined that this subsequent discretionary approval of the Tecolote Canyon Mitigation

Project does not involve change in circumstances, project changes, or new information of substantial importance which would warrant any additional environmental review.
