That the Council further states for the record that the information contained in EIR No. 6020 (Canyon Sewer Cleaning Program), including any comments received during the public review process, has been previously reviewed and considered by this Council and it is determined that this subsequent discretionary approval of the Rancho Mission Canyon Wetland Enhancement Project does not involve change in circumstances, project changes, or new
