A RESOLUTION AUTHORIZING EXPENDITURE OF \$720,000 FOR THE JUDICIAL DRIVE—GOLDEN HAVEN DRIVE TO EASTGATE MALL, CIP 52-678.0, PER THE REIMBURSEMENT AGREEMENT WITH MAKALLON LA JOLLA PROPERTIES, LLC

WHEREAS, Makallon La Jolla Properties, LLC [Makallon] is constructing the Judicial Drive undercrossing at La Jolla Village Drive [Undercrossing] as part of CIP 52-678.0, Judicial Drive–Golden Haven Drive to Eastgate Mall, and in satisfaction of a condition of approval of Makallon's development project, La Jolla Commons, the vesting map of which (VTM No. 99-0762) the Council of the City of San Diego [Council] approved by Resolution R-294149; and

WHEREAS, the Council approved by Resolution R-297185 a reimbursement agreement [Agreement] whereby the City of San Diego will reimburse Makallon for its approved expenditures in constructing the Undercrossing; and

WHEREAS, the estimated cost for construction of the Undercrossing was \$7,469,000; and

WHEREAS, the Agreement provides that Makallon may be reimbursed for construction expenditures that exceed the original estimated amount, contingent upon the necessary additional funding being included in the North University Public Facilities Financing Plan; and

WHEREAS, the actual cost of construction of the Undercrossing exceeds the original estimated amount by \$720,000; and

WHEREAS, the additional \$720,000 for reimbursing Makallon is available from North City Facilities Benefit Assessment Funds and was approved to be included in the North University City Public Facilities Financing Plan by Resolution R-299403;

THEREFORE, BE IT RESOLVED, by the Council, that the City Auditor and Comptroller is authorized to appropriate and expend \$720,000 from CIP No. 52-678.0, Judicial Drive – Golden Haven Drive to Eastgate Mall, Fund 79001, Facilities Benefit Assessment Fund, per the terms of the Agreement with Makallon, contingent upon the Auditor and Controller first certifying that the funds are available with the City Treasurer; and

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves; and

## BE IT FURTHER RESOLVED, that this activity is covered under the EIR in LDR File No. 99-0647, dated October 6, 2000.
