WHEREAS, over the past twenty years, SummerFest has involved more than 550 artists and ensembles, four talented artistic directors, and millions of audience members at its concerts and through the radio on National Public Radio; and

WHEREAS, La Jolla Music Society SummerFest has featured prominent visual artists such as Daly Chihuly, Italo Scanga, Stephen P. Curry, Caio Fonseca, Madelynne Engle, Gail Ohyama, and Manny Farber; and

WHEREAS, La Jolla Music Society SummerFest, a leader in commissioning new works, looks to the future with a record-breaking six premieres of new commissioned works, as well as great jazz and dance performances; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby proclaim Thursday, August 3, 2006, "LA JOLLA MUSIC SOCIETY SUMMERFEST DAY" in San Diego for its significant contributions to San Diego's artistic and cultural identity for twenty years.
