BE IT RESOLVED, that the Docket Supporting Information [City Council Report No. 06-078], including all exhibits and attachments thereto, and the text contained in the Pacific Highlands Ranch Public Facilities Financing Plan and Facilities Benefit Assessment,

Fiscal Year 2006, a copy of which is on file in the office of the City Clerk as Document No. RR-30160 [R-2006-1075] are incorporated by reference into this Resolution as support and justification for satisfaction of findings required pursuant to California Government Code sections 66001(a) and 66001(b) for imposition of DIFs. Specifically, it is determined and found that this documentation:

- 1. Identifies the purpose of the DIF;
- 2. Identifies the use to which the DIF is to be put;
