
DATE OF FINAL PASSAGE AUG 15 2006

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor be and he is hereby authorized to execute a Service Agreement with the Bird Rock Development Corporation for administration of Contracts for Goods and Contracts for Services for the Bird Rock Maintenance Assessment District for a period of twelve-month period beginning July 1, 2006, in accordance with the San Diego Municipal Code section 65.0212, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to appropriate and expend an amount not to exceed \$24,750 from Fund No. 70281, Bird Rock Maintenance Assessment District, for administrative fees incurred by the Bird Rock Development Corporation in the course of providing services under the Service Agreement, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds are available.
