DATE OF FINAL PASSAGE AUG 15 2006

RESOLUTION OF THE CITY OF SAN DIEGO AUTHORIZING AN AGREEMENT WITH THE COUNTY OF SAN DIEGO FOR USE OF THE CITY'S HOUSEHOLD HAZARDOUS WASTE TRANSFER FACILITY; DIRECTING THAT FUNDS RECEIVED FROM THE COUNTY BE DEPOSITED TO THE RECYCLING FUND; AND AUTHORIZING SIMILAR AGREEMENTS WITH OTHER LOCAL JURISDICTIONS.

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor or his designee is authorized to execute, for and on behalf of the City, an agreement with the County of San Diego, for residents of unincorporated areas to use the City's permanent household hazardous waste transfer facility, under the terms and conditions set forth in the Agreement, on file in the office of the City Clerk as Document RR- 301829, including options to renew the Agreement for three additional one-year periods.

2. That the City Auditor and Comptroller is authorized and directed to deposit funds received under the above Agreement into Recycling Fund No. 41210.

3. That the Mayor or his designee is authorized to execute amendments to the above Agreement exercising the renewal options and amending the Agreement as necessary to reflect changes in services, responsibilities, costs, and funding.

4. That the Mayor or his designee is further authorized to enter into similar agreements containing similar terms including, but not limited to, similar mutual indemnity provisions, with other local jurisdictions for their use of the City's household hazardous waste transfer facility.

5. That this activity is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines section 15061(b)(3) because it can be seen with certainty that there is no possibility this activity will cause a significant impact on the environment.
