DATE OF FINAL PASSAGE AUG 1 5 2006

WHEREAS, Chollas and Paleta Creeks carry urban runoff from the City of San Diego, flowing into and through Naval Station, San Diego and emptying into San Diego Bay;

WHEREAS, Chollas and Paleta Creeks are listed impaired waters under Section 303(d) of the federal Clean Water Act, and require special attention to the levels of pollutants contained in their waters;

WHEREAS, the California Regional Water Quality Control Board. Region 9 has investigated and is monitoring Chollas and Paleta creeks as sources of pollutants into San Diego Bay;

WHEREAS, both creeks accumulate and carry trash and pollutants onto the Naval

WHEREAS, the trash and pollutants can be contained by oil booms laid across the creek surfaces where the creeks pass through Naval Station San Diego;

WHEREAS, the booms provide satisfactory temporary containment in normal weather conditions, but cannot contain all trash during rain events;

AND WHEREAS, The City and U.S. Navy wish to work cooperatively to remove trash from Chollas and Paleta creeks;

BE IT RESOLVED, by the Council of The City of San Diego, that the Mayor be, and hereby is, authorized and empowered to execute, for and on behalf of said City, an agreement with the U.S. Navy for services required to remove debris from Chollas and Paleta Creeks.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$35,000 is hereby authorized, solely and exclusively for the purpose of providing funds for the above services, contingent upon the Auditor and Comptroller first furnishing one or more certificates certifying that the funds are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that this action is exempt from the California Environmental Quality Act pursuant to CEQA Guidelines sections 15301(i), as the maintenance of existing facilities.
