A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN ADDITIONAL \$110,000 FOR THE CONTINUED CONSTRUCTION OF THE HILLCREST STREETSCAPE IMPROVEMENTS: UNIVERSITY AVENUE – VERMONT STREET TO HERBERT STREET.

WHEREAS, the Hillcrest Streetscape Improvements: University Avenue – Vermont Street to Herbert Street (CIP No. 39-213.1) [Project] is part of a series of streetscape improvement projects located in the Uptown Community area of the City; and

WHEREAS, the present action increases the FY 2007 budget for the Project by \$110,000 (from \$1,684,829 to \$1,794,829) to pay for additional work necessary to complete the sidewalk, curb, and gutter areas along University Avenue (from Vermont Street to Richmond Street) resulting from several unforeseen conditions found at the site; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the FY 2007 Capital Improvements Program Budget for the Hillcrest Streetscape Improvements: University Avenue Vermont Street to Herbert Street (CIP No. 39-213.1) [Project] is amended by increasing the budget amount by \$110,000.
- 2. That the City Auditor and Comptroller is authorized to transfer \$110,000 from Fund No. 79512 (Uptown Developer Impact Fees) to CIP No. 39-213.1 for the continued construction of the Project, contingent upon certification of funds availability by the City Auditor and Comptroller.
- 3. That the Mayor or his designee is authorized to execute Change Order No. 4 for the continued construction of the Project, contingent upon certification of funds availability by the City Auditor and Comptroller.

- That the City Auditor and Comptroller is authorized to appropriate and expend the 4. \$110,000 transferred to CIP No. 30-213.1 for the continued construction of the Project.
