A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF THE FISCAL YEAR 2007 OPERATING AGREEMENTS FOR THE EXISTING BUSINESS IMPROVEMENT DISTRICTS.


