WHEREAS, Ms. Hamilton has received numerous honors for her exceptional service including the U.S. Department of Housing and Urban Development Superior Service Awards and Presidential Award; the Individual Award from La Mesa Beautiful, Inc.; the San Diego YWCA's Tribute to Women and Industry Award; the San Diego Woman of Accomplishment

Award; the Woman of Achievement Award from the President's Council of Women's Service, Business and Professional Clubs of San Diego; the Pioneer Award from the Gaslamp Quarter Historical Foundation; the Alonzo Award from the Downtown San Diego Partnership; and the International Public Official Award at the 1997 Lambda Alpha International Biennial Congress; NOW, THEREFORE,
