WHEREAS, the City Council finds that:

- (a) there is no present or prospective use for the Easement, either for the purpose for which it was originally acquired, or for any other public use of a like nature that can be anticipated;
  - (b) the public will benefit from the vacation through improved utilization of land;
  - (c) the vacation is consistent with the General Plan or an approved Community Plan; and
- (d) the public facility or purpose for which the Easement was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Easement is ordered vacated.
- 2. That the City Clerk shall cause a certified copy of this resolution, with attached exhibits, attested by him under seal, to be recorded in the Office of the County Recorder.
