WHEREAS, Peggy's volunteer work has improved the quality of life for the residents of the City of San Diego; and

WHEREAS, Peggy's outstanding service to the Clairemont community and pride in her City make her a well-deserved honoree at the 17th Annual 2006 Clairemont Family Day Celebration; and

WHEREAS, Peggy is a shining example of being the change she wants to see in the world; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby commend Peggy Maloney for her dedicated service and tireless work for the people of Clairemont and all of San Diego.

BE IT FURTHER RESOLVED, that July 29, 2006, be and is hereby proclaimed to be "PEGGY MALONEY DAY" in the City of San Diego.
