WHEREAS, Noelle resumed her roles in Community Affairs and as Treasurer after taking a leave to care for their newborn baby, Faith; and


WHEREAS, Tom and Noelle Miller, who will be leaving San Diego, will be sorely missed as the many projects that have benefited from their contributions come into fruition;


