A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING A COOPERATIVE AGREEMENT WITH THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO FOR THE FINANCING OF PARK IMPROVEMENT PROJECTS IN THE COLLEGE GROVE REDEVELOPMENT PROJECT AREA.

WHEREAS, on May 19, 1986, the Council of the City of San Diego [City Council], adopted Ordinance No. O-16647 (New Series), on file in the office of the City Clerk as Document No. OO-16647-1, approving and adopting a Redevelopment Plan for the College Grove Redevelopment Project Area [Plan]; and

WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] is engaged in activities necessary to implement the Plan; and

WHEREAS, the City and Agency are mutually desirous of implementing the Plan by installing public improvement projects within the Chollas Recreation Area; and

WHEREAS, the City and Agency are mutually desirous of entering into a Cooperative Agreement, which obligates the Agency to contribute available tax increment from the College Grove Redevelopment Project for the future City implementation of the public improvement projects; NOW, THEREFORE,

BE IT RESOLVED by the Council of the City of San Diego that the City approve a Cooperative Agreement with the Agency, which document shall be on file in the office of the City Clerk as Document No. RR-301889.

BE IT FURTHER RESOLVED, that this activity is not a "project" and is therefore exempt from California Environmental Quality Act [CEQA] pursuant to the State CEQA Guidelines Section 15060(c)(3).
