WHEREAS, Gary Halbert was selected as the new Director of the Development Services Department in 2004 after competing for the job against qualified applicants from all over the nation; and

WHEREAS, as part of his Customer Service Initiative, he created and implemented major departmental reforms which made the department more efficient and easier for citizens to navigate; and

WHEREAS, in his time at the City, Gary Halbert has inspired those around him with his attitude and intelligence, creating fun and productive work environments that served San Diego's citizens while maintaining the highest professional standards; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the citizens of San Diego, does hereby proclaim September 19, 2006, to be "GARY HALBERT DAY" in the City of San Diego.
