1. That the Mayor or his representative is hereby authorized and empowered to execute, for and on behalf of said City, the Third Amendment to the Agreement with Lintvedt, McColl & Associates for additional professional services, under the terms and conditions set forth in the document on file in the office of the City Clerk as Document No. RR- 301910 for CIP 52-583.0, La Jolla Parkway/Torrey Pines Reconfiguration Project, in the amount of \$21,385, Fund 30300, Transnet.

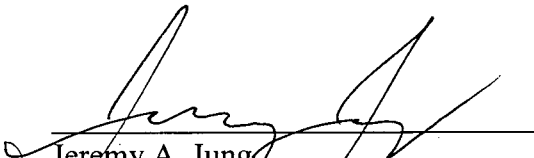

3. That the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.

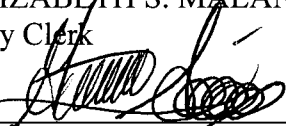
